ENGLISH AS A SECOND LANGUAGE (ESL) STUDENT ACKNOWLEDGMENTS AND ENROLLMENT AGREEMENT

CANCELLATION AND REFUND POLICIES

<u>Rejected Applicants</u>: An applicant who is rejected admission into the English as a Second Language (ESL) program, will be refunded all monies paid.

<u>Three-Day Cancellation</u>: An applicant who provides written notice of cancellation within three days (excluding Saturday, Sunday and federal and state holidays) of signing an enrollment agreement or making their payment, whichever is the latest act to occur, is entitled to a refund of all monies paid. No later than 30 days of receiving the notice of cancellation, University of the Potomac shall provide a 100% refund.

<u>Other Cancellations</u>: A student has the option to withdraw from University of the Potomac by giving notice of their intent to terminate enrollment in writing. In the absence of the student giving written notification, the student is dismissed from University of the Potomac after 3 (three) consecutive days of non-attendance.

When determining refunds, the number of days enrolled is calculated from the start date for the program to the withdrawal date. The student's withdrawal date is either the date the student notifies University of the Potomac in writing of the intent to withdraw, or the date University of the Potomac determined that the student was no longer attending classes, usually 3 (three) calendar day after the date of last attendance. Class times missed due to absences are included. Times out of class due to an approved/excused absence, termination and re-enrollment, and University of the Potomac's schedule/unscheduled closure dates are excluded.

University of the Potomac's English as a Second Language (ESL) program tuition is charged on a program basis. All fees are nonrefundable. University of the Potomac's refund policy generally allows the school to earn 100% of the charges from students who complete 60% or more of the program. The date of a student's withdrawal is established when University of the Potomac determined the student was no longer attending classes. University of the Potomac may take up to 5 (five) days from the last date of attendance to make the determination that the student was no longer attending classes.

If applicable, refunds to agencies, private loans, scholarships, and to the student will be made within 30 days of the date the student is determined to have withdrawn. Students will be sent a notification of all refunds made. Although the staff cannot advise students on when to withdraw from the program, students are encouraged to become familiar with the refund policies, make their own decisions and take the appropriate actions. All other charges are non-refundable.

TERMS AND CONDITIONS

I understand that the terms within University of the Potomac catalog are incorporated as part of this enrollment agreement. I agree to abide by all terms within University of the Potomac catalog and understand that my enrollment may be terminated if I fail to comply with the rules, regulations, and financial requirements.

ARBITRATION AGREEMENT

Any dispute I may bring against University of the Potomac, or any of its parents, subsidiaries, officers, directors, or employees, without limitation, or which the school may bring against me, no matter how characterized, pleaded or styled, shall be resolved by binding arbitration, conducted by the American Arbitration Association, under its Consumer Rules, and decided by a single arbitrator. The arbitrator will decide the case pursuant to the Federal Arbitration Act, and under the laws of the state of District of Columbia, U.S.A. Any dispute over the interpretation, enforceability or scope of this Arbitration Agreement shall be decided by the Arbitrator, and not by a Court. I explicitly waive any right I may have to a jury trial, and understand that the decision of the arbitrator will be binding, and not merely advisory.

Neither University of the Potomac nor I shall file any lawsuit against the other in any court and agree that any suit filed in violation of this provision shall be promptly dismissed by the court in favor of arbitration. Both University of the Potomac and I agree that the party enforcing arbitration shall be awarded costs and fees of compelling arbitration.

The costs of the arbitration filing fee, arbitrator's compensation, and facilities fees that exceed the applicable court filing fee will be paid by University of the Potomac.

I agree that any dispute or claim I may bring shall be brought solely in my individual capacity, and not as a plaintiff or class member in any purported class action, representative proceeding, mass action or consolidated action. Any remedy available from a court under the law shall be available in the arbitration.

I certify that the information in this application and enrollment agreement are true, complete, and correct to the best of my knowledge. I hereby apply for admission to University of the Potomac's English as a Second Language (ESL) program and agree to abide by its regulations.
